

## 14.2 COUNCIL ASSESSMENT PANEL – APPOINTMENT OF MEMBERS

Cr Knoblauch moved:

*That pursuant to Sections 90(2) and (3) of the Local Government Act 1999, the Council orders that the public, with the exception of the Council staff present [Chief Executive Officer, General Manager, Urban Planning & Environment, Chief Financial Officer, General Manager, Infrastructure & Major Projects, General Manager, Community Development, Manager, Development & Regulatory Services, Manager, Urban Planning & Sustainability, Senior Urban Planner and Executive Assistant, Governance & Civic Affairs], be excluded from the meeting on the basis that the Council will receive, discuss and consider:*

*(a) Information the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead);*

*and the Council is satisfied that the principle that the meeting should be conducted in a place open to the public has been outweighed by the need to keep the receipt / discussion / consideration of the information confidential.*

Cr Robinson moved:

*That the Council notes that the Deputy Elected Member appointed to the Council Assessment Panel, may act in the place of the Elected Member when they are unavailable, but may not act in the place of any Specialist External Member. The Deputy Specialist External Member may act in the place of any Member when they are unavailable, but may only act in the place of the Elected Member when both the Elected Member and Deputy Elected Member are absent.*

Cr Duke moved:

*Under Section 91(7) and (9) of the Local Government Act 1999, the Council orders that the report and attachments be kept confidential for a period not exceeding five (5) years and that this order be reviewed every twelve (12) months.*

*Under Section 91(7) and (9) of the Local Government Act 1999, the Council orders that the discussion and minutes be kept confidential until the announcement of the appointments is made.*
